Your input matters

The flow-based implementation process includes a quality control by the Nordic National Regulatory Authorities (NRAs), assessing an evaluation report of the external parallel run. Before the report is submitted, there is an open consultation, providing stakeholders with the opportunity to provide input on the report.

After the consultation period is closed, the Nordic TSOs will compile the input received, and use it to complete the report and submit it to the NRAS for assessment.
