

Nordic CCM Market Report: 2023 Week 19

General Remark

This week sees an overall positive change for the Nordic CCR of 8.35 M€, a change of -0.21 M€ on the Hansa/Baltic border, and a change of -0.25 M€ for the external areas, resulting in a change of 7.89 M€ for the entire SDAC area.

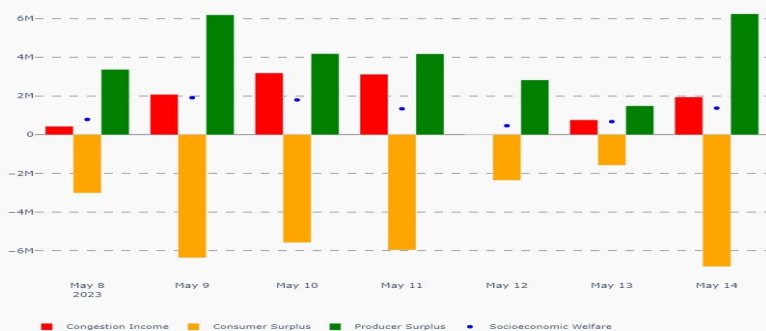
The daily SEW in the Nordics is larger with FB than NTC for all days of week 19. The week overall had relatively low prices, contributing to higher relatively price changes between NTC and FB.

For May 11th a backup/fallback domain was applied for the whole day due to a mismatch between files and an IT update. This had no major market impacts on the Nordic level, e.g. on the Nordic SEW or total Nordic net position. However, the use of fallback-domains resulted in the configuration of the Svk series compensators being wrong thus limiting the flow on cut 2 more than necessary. In the Svk IGM an outage on May 13th was not taken into account correctly causing two CNECs to be very limiting in the market coupling results.

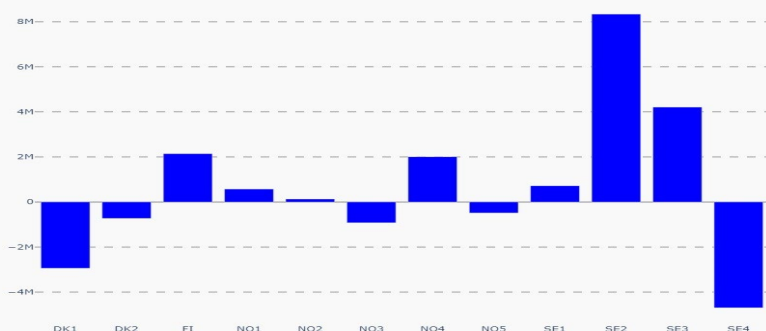

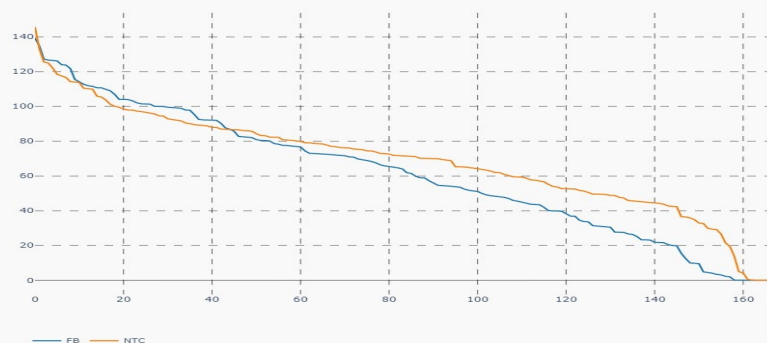

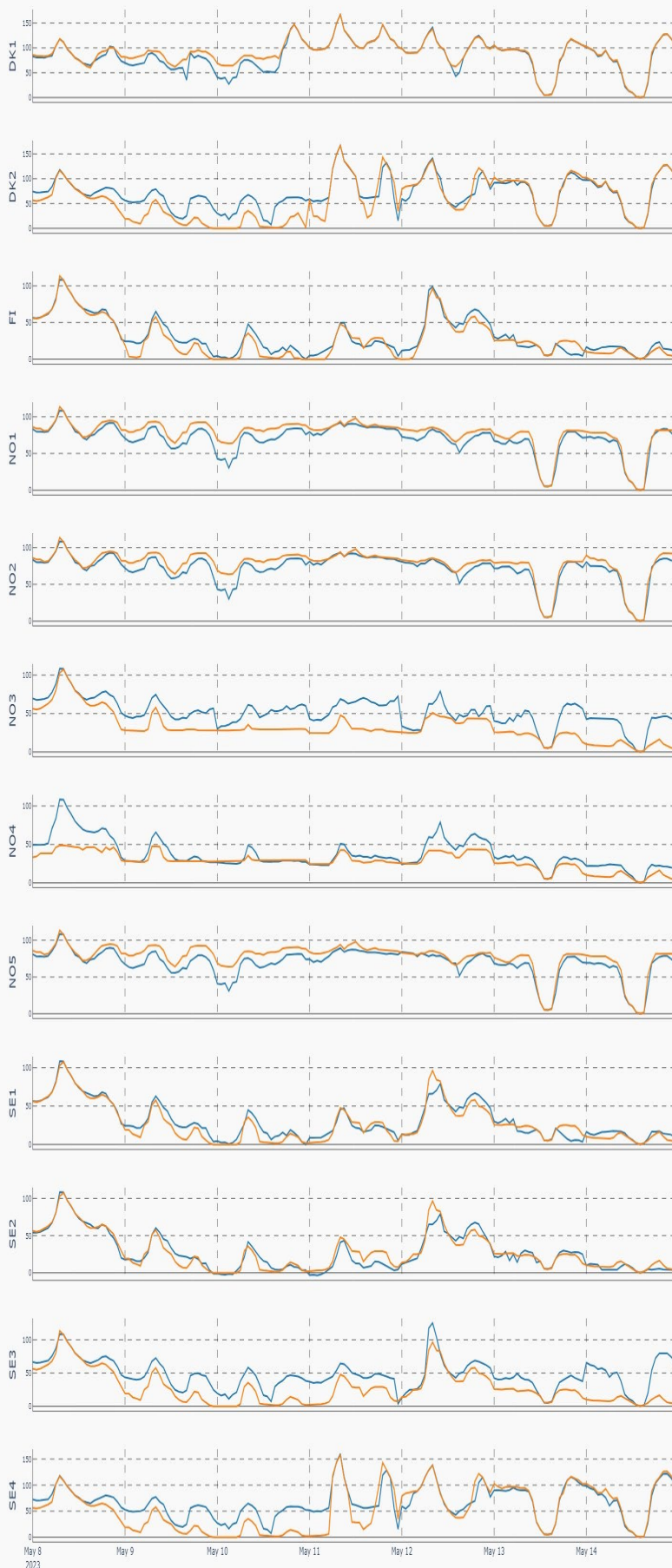
Nordic Prices – Duration Curve (€/MWh)
