In their communication regarding the 3-month EPR report, the Nordic NRAs concluded that there are open issues still remaining beyond the key performance indicators (KPIs). The Nordic TSOs are currently in contact with the Nordic NRAs to clarify these issues as well as the NRAs' expectations.
