

Nordic CCM Market Report: 2024 Week 12

General Remark

This week sees an overall change for the Nordic CCR of -2.08 M€, a change of 2.68 M€ on the Hansa/Baltic border, and a change of -0.24 M€ for the external areas, resulting in a change of 0.35 M€ for the entire SDAC area.

This week shows negative SEW results for the Nordics, but a SEW gain for the entire SDAC area. From Monday to Friday, the results show a positive impact on the total SDAC SEW. This is because FB manages a higher flow to the continent, which shift welfare to the Hansa borders and the continent.

On Saturday and Sunday the welfare becomes negative. This is due to the Sauda transformers in NO2 limited flow to NO5 and from the continent to avoid overloads, which caused a lower SEW but provided higher operational security.

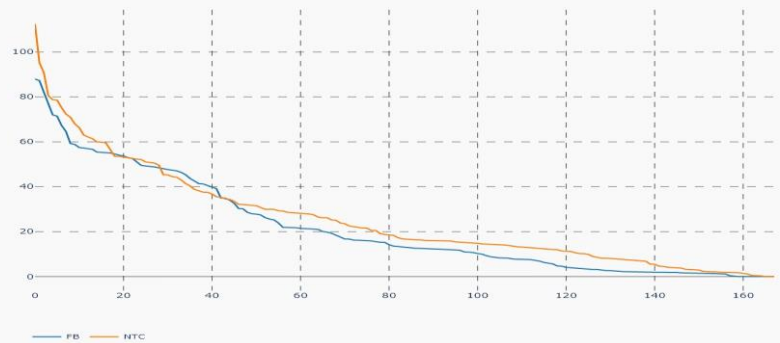
