









Where do we come from and where are we now?







Where do we come from and where are we now? Focus on the ID ATCE



- The ATCE is an optimization procedure, to maximize the capacity for the ID market from the left-over DA FB capacity
- A relaxation of the FB domain is needed to find a solution
- The original relaxation applied was (intentionally) generous, but raised concerns at the TSO operators as there would not be sufficient time during the validation to reduce the capacities where needed to safeguard the operational security
- The relaxation has now been adjusted, to strike the balance between market facilitation and operational security, which required an update of the industrial tool as well


