Nordic CCM Market Report: 2024 Week 21

General Remark

This week sees an overall change for the Nordic CCR of -3.78 M€, a change of 6.63 M€ on the Hansa/Baltic border, and a change of 0.34 M€ for the external areas, resulting in a change of 3.18 M€ for the entire SDAC area.

The negative SEW change for the Nordic CCR is due to the congestion income moving from within the Nordic CCR to the Hansa borders. This shift is most notably due to the increased flow between SE3 and SE4 during hours with large price differences, which decreases prices in SE4 and moves the congestion income to the Hansa borders instead remaining within Sweden.

For EDD 23rd of May, the IGM files generated by Fingrid were for the wrong EDD and could not be used. This issue was not fixed in time, which led to 24 backup domains being used.




Daily Nordic Socio-economic Welfare (M€)




Nordic Prices – Duration Curve (€/MWh)

Nordic Net Position


